### SKILLET LICKERS LEADER RETURNS

Gordon Tanner of Dacula, leader of the Junior Skillet Lickers country music band, is returning to repeat his popular program on old-time music that entertained thousands in Gwinnett County in years past.

Program Chairman Charlie Pentecost announces that Mr. Tanner will be the featured speaker and entertainer at the February 16, 7:30 P. M. meeting of the Gwinnett Historical Society, in the restored Female Seminary, Lawrenceville. Mr. Tanner's repeat program is by request and for the benefit of our many new members. The public is invited.

He will tell about his famous father, Gid Tanner, whose fiddling record "Down Yonder" sold more than a million copies, and placed Gid Tanner in country music's Hall of Fame in Nashville, Tennessee. His record will be played at the Society's February meeting.

Gordon Tanner will demonstrate the difference between violin and fiddler music, and display some of his valuable hand-made violins.

Nearly 100 persons were enthralled by Gordon Tanner's performance and lecture at the Society's February meeting a year ago.

# QUILT TO GO IN BANKS AND BOOKS

The 25-block handmade historical Gwinnett County quilt, made by Mrs. Mercer E. (Lucile) Baldwin and quilted by eleven women from Sweetwater Chapel Quilters, will be displayed at various banks this year, accompanied by a written description of each historic site depicted on the quilt. Mrs. Baldwin has already told the story of the quilt to several PTA, Scout and church groups.

The quilt was exhibited at the Norcross branch of Tucker Federal Savings and Loan Association the last of January.

It was scheduled for showing at the Highway 20 branch of Buford's Commercial Bank, February 1 to February 16; and at the Bank of Duluth, Duluth, GA. February 16 to March first.

From there it goes to banks in Lawrenceville, Lilburn, and Snellville.

The quilt will be included in a book about pictorial quilts by Nina Holland to be published this year by A. S. Barnes & Co., Plattsburg, N. Y. For this purpose, it had to be given a name. The Executive Council of the Gwinnett Historical Society decided on GWINNETT COUNTY, GEORGIA, HISTORY QUILT.

As part of our Bicentennial celebration, Gwinnett Historical Society is attempting to compile a list of Revolutionary War veterans who are buried in Gwinnett County. So far, we know of six. Alice McCabe is also listing all other Gwinnett-related Revolutionary vets who settled or lived awhile in Gwinnett County. Information on this subject can be relayed to Mrs. McCabe, 2045 Northland Dr., Lawrenceville, or phone 963-9584. To date, we are aware of 165 veterans of the War for Independence who had a connection with Gwinnett County.

### POWER OF THE PRESS AND TRACY

When Ginger Kaderabek of the Atlanta Journal ran a story and picture of our member-author J. Tracy rower in the January 2 edition, the response was amazing. Although the story gave no home address for him, Tracy so far has received ten orders for his book, "An Index to Confederate Soldiers in Gwinnett County, Georgia, During the War Between the States." One man telephoned him from Jonesboro. One sent a check via Berkmar High School, where Tracy is a senior. Tracy expects to sell more books when he addresses the Atlanta Chapter, United Daughters of the Confederacy. Although the supply is dwindling, the books are still available for \$2.00 at our Gwinnett Historical Society meetings and for \$2.50 by mail, Address - P. O. Box 261, Lawrenceville, GA. 30245. About 300 books have been sold to residents in eleven states.

# SACRED HARP SINGERS AND QUILT AT NOVEMBER MEETING

Haynes Creek Primitive Baptist Church "Fa Sol La" singers, led by various members, sang several Sacred Harp hymns at our November meeting. Mrs. J. C. Wade told of the Sacred Harp arrangements dating back to 1500, through the songs of B. F. White and E. J. Kean on to the Dennison's hymnal being taught in colleges today. She writes: "Still looking for marriage record of Wm. P. HUTCHINS to Sallie Ann DILLARD, both from Georgia. I believe John P. HUTCHINS is the father of Wm. P. In the 1880 Arkansas Census, Wm. stated his father was born in S. C."

Answer: Sent list of all ten HUTCHINS burials in the old Lawrenceville Cemetery-none for John P.

Mrs. Widener offers to check for Arkansas ancestors for GHS members. She has access to 1840 census, soldiers by rank and county who fought in Texas Revolution 1846 and Biographical Index of Arkansas.

Virginia P. Keinz, 32676 Utica Rd., Fraser, MT. 48026 is looking for ancestors who were in various wars who "fought in your County or State." Among the names she lists are James WEST, Thomas, William Henry, and Edward TENCH; Thomas, John, Elijah, Peter KINSEY; Marshall, Jesse and John LOVELADY and Christopher SMITH.

Answer: Not in Vol. 1, History of Gwinnett County or in list of Gwinnett marriages or Revolutionary men/women in land lotteries. One brief entry, p. 295, in "Gone to Georgia"; David Kinsey (also Kinzie) was in 1805 Jackson County, GA. lottery. In 1820 Peter was in Habersham County. In Warren County, were Edward, John and Martin Kinsey. Two Peters were in Pendleton District, S. C., in 1790, and in 1800 Peter and William were enumerated there. Thanks to the Lanier Lake Regional Librar Lawrenceville, for the above research.

Marvin Worthy and I have a common ancestor -John H. BENNETT, buried at Haynes Creek.

My mother remembers reading the Atlanta Constitution to her great grandparents, John G. and Sarah A. BENNETT, when she was a little girl...John G.'s father John was one of the founders of Haynes Creek in 1826. My husband is related to the CRAIGS of Gwinnett. His native county is Stephens (Toccoa). We enjoy your Newsletter and anticipate the future ones.

Mrs. Ilah W. Fleming, 111 S. Lakemount Ave. #240, Winter Park, FL. 32789 writes: Can anyone give the parents' names of William S. HARRIS and Cinthia ADAMS who were married in Walton County 12 August 1825? They lived their entire married lives in Gwinnett and are buried in New Hope Methodist Church cemetery. The 1864 Manpower Census for the Civil War gave birthpl of William S. HARRIS as Anderson, S. C. There was a Jerusha HARRIS married 1808 in S. C. to William KING by Presbyterian minister. The KINGS lived in Gwinnett near Old Center Church and had sons William S. and Stephen. William KING gave affidavit on pension app. of Polly HARRIS as having known her in South Carolina.

Answer: 1 -According to records of Franklin Garrett, who listed tombstones at New Hope M. E. Church, there are only two graves marked there: David and Elizabeth PREUTT. If Mrs. Fleming knows for sure they are buried in old New Hope Methodist in Harbins District, they must be among the unmarked stones there.

Answer: 2 -We are not aware of any church in Gwinnett named "Old Center." Could it be Old Field or Old Salem?

Answer: 3 -These names are not listed in Gwinnett marriages 1835-75. But there are two whose names might have been misinterpreted: V. S. KING (middle name could be Stephen) married M.E.C. KENNERLY 1873. H. M. KING (W could be mistaken for H) married M. E. HAMILTON 1872-GHS sent Harris and Adams in 1830 Walton Co. census.

Many of the QUINN family came from DeKalb Co. --Do you know anyone who could check the records there? 1:11 be so glad to check HOPKINS & CAMP counties, TX. for any Georgians whose ancestors moved here.

Answer: DeKalb was formed in 1822 from Gwinnett, Fayette, Newton and Henry. Their courthouse burned in 1842. Superior Court Clerk has land records from 1842. Does anyone want to go to Decatur and look up Eber and Charlie Edward QUINN, b. about 1850-60-Gwinnett-DeKalb?

John Moore, 470 Valley Rd. 7-A, Upper Montclair, N. J. 07043, is seeking information on a wooden enclosure or fence that surrounded MATTHEWS graves in the old Liberty Baptist Church cemetery, Lilburn. Names and dates were carved or painted on the fence in lieu of stone markers. It was last known to have been in place in the 1920's, but was subsequently torn up and thrown into the woods where it probably rotted away. Does anyone have a record of what was written on the fence?

# COMMATALIST IN OUR MIDST

Before throwing out old letters, Gwinnett Historical Society members might keep in mind a new member, Mrs. Paul R. Moore, 904 Hwy 29, Lawrenceville, GA. 30245. Mrs. Moore is a commatalist who has thousands of post marked envelopes from the whole USA but lacks many from Georgia. Through post marks, ranging from standard collectible 2 x 4 sizes to hand-cancels, and machine cancels, Mrs. Moore traces the origin of towns. The small towns, she says, are especially interesting. Mrs. Moore will be pleased to pay a small fee for any envelops (called "entries") that our members can send to her-especially from old towns in Georgia. Here's a way to help a new member whose arthritis may keep her from attending meetings, but doesn't stop her from pursuing a fascinating hobby.

### SOCIETY HAS OWN CHAPLAIN

For the first time the Gwinnett Historical Society now has a Chaplain, the Rev. Kirk Nesbit, the great, great grandson of William Nesbit, the second sheriff of Gwinnett County.

William Nesbit was born in 1789 and died in 1863. He is buried in a small cemetery off the Lawrenceville Highway (US 29), near the Gwinnett-DeKalb County line.

He was one of three men commissioned in 1812 to cut historic Peachtree Road from Fort Daniel near Hog Mountain to Fort Gilmer at Standing Peachtree. The men were paid \$150 for cutting the road.

Our Chaplain's great grandfather was Sylvester Nesbit, a Confederate Veteran who lived in old Milton County. His grandfather was Frank Nesbit who lived in Norcross and had eight sons, four of them still living in and around Norcross.

Kirk's father is Noye Nesbit of Norcross, who observed his 81st birthday last December 7. He was with Standard Oil Company for years, and operated Gwinnett County's pumping station at Duluth about 15 years.

Kirk Nesbit is a mechanical engineering graduate of Georgia Tech, a graduate of Columbia Seminary at Decatur, and presently is pastor of the Hemphill Memorial Presbyterian Church near Stockbridge, GA.

# PLEDGE TO FLAG -EUGENE CHATHAM

The Historical Society is honored to have Eugene Chatham, a 15-year-old, 10th grader at Norcross High School, lead the pledge to our flag at meetings this Bicentennial year.

At flag pledge ceremonies Eugene wears a Confederate Cavalry shell jacket which his mother, Mrs. Roe Chatnam (the former Annette Warbington) made for him. She copied it from a book on Confederate uniforms, laying it out by patterns. and putting it together on a sewing machine.

Eugene wore a replica of General Robert E. Lee's coat at flag pledging ceremonies a few years ago. It also was made by his mother. With his new uniform, Eugene carries an 1860 Confederate Cavalry sabre.

### CHAIRMAN TODD

Congratulations to Mrs. T. E. (Helen) Todd on her appointment as Chairman of the Gwinnett Historical Restoration and Preservation Board, which restored the 140-year-old Lawrenceville Female Seminary.

### PRESERVE VALUABLE PAPERS

Document Conservation Center has opened at the Atlanta Historical Society building, 3099 Andrews Drive, N.W., Atlanta. The Conservator, Harold H. Moore, can be reached by phoning 261-1837. He has done archival conservation work for eleven years and was a commercial bookbinder for four years. His assistant is Midge Brannon, with four years part-time archival conservation experience.

DCC is set up to restore and preserve documents, letters, blueprints, drawings, clippings, etc. They use either cellulose acetate lamination or mylar encapsulation processes. Prices range upwards from \$20 a sheet.

### MATTHEWS CEMETERY

On old US 29, Land Let 149, Lilburn, west of Lawrenceville, behind old Matthews house (now called the Young house).
